Potential of the Project

Beyond supporting individual users, this app has the potential to serve as a bridge between migrant entrepreneurs and host economies across Europe. After validating our model in Germany, we plan to scale to other European countries, creating localized resources and support systems. Ultimately, our vision is to build a platform that facilitates the integration of migrant entrepreneurs across Europe, fostering economic independence and growth for individuals and communities alike.

Monetization

Our monetization strategy includes a subscription model for premium features like document storage, categorization, and advanced Al support. A 30-day free trial allows users to explore these features and experience the app's value in managing their business documents and resources.

In the first years of project implementation, we plan to attract financing from various investment funds. we are considering the possibility of financing both from Ukrainian sources, for example: Ukrainian Startup Fund, Startera. We also want to attract funding from the EU, it can be AMIF - Asylum, Migration and Integration Fund of the European Union, Bundesagentur für Arbeit, Finanzierung Berlin, as well as regional funding programs in Germany.
